- Regular Meeting Minutes of the Board of Trustees for July 13, 2022

- b. Treasurer's report for July 31, 2022 including a fund transfer in the amount of \$596,580.42 that includes the catch up of \$162,000.00 to the State for the Ground Emergency Management Transportation.
- c. Disbursements for the date ending July 31, 2022 in the amount of \$322,578.23
- d. Warrants for the date ending August 9, 2022 in the amount of \$20,073.00
- IV. Fire Commissioners Report

Commissioner Olender reported Commissioners all good. No report and no meeting of the Commissioners tonight. Working on current vacancy.

- V. Fire Chief's Report
  - a. Firefighter Kingsmill was granted his duty disability pension effective October 1, 2021. President Kunze thanked Tim for his many years of service.
  - b. Chief Schneidwind asked for consideration to enact Ordinance No. 2022-01 amending Structure of Department, and this was in coordination with side letter of promotions.
  - c. Consideration asked for Promotion proposal and side letter.
  - d. Consideration to purchase rescue equipment. We put this out to bid and received one bid from Air One in the amount of \$32,645.00. Discussion with FFIB and they agreed to pay for half of this. Additional \$4000.00 needed for bracketing, brining half the cost to approximately \$18,500.00. Thank you FFIB.
  - e. Consideration to approve rezoning as proposed by the Village of Itasca
    Chief informed the Board the Village asked us to change residential zoning to B2 and
    waive all fees related to that. Trustee McDonald and Chief met with Building
    Committee today to discuss with architect.
  - f. Mike Lisek and I attended a Town Hall meeting the other night regarding railroad merger conducted by Congressman Raja Krishnamoorthi. Basically, this is a 31.5 billon dollar deal between the two railroads expected to be complete in 2023. This will impact our town greatly. Another meeting is scheduled for September 12 to held at Village Hall with NTSB from Washington attending.
    - Chief Schneidwind passed map out of Itasca for discussion regarding railroad. Statistical data for emergency responses 2003-2021, July 2022 incidents, July 2022 mutual aid calls and apparatus B66 yearly call totals and delays for discussion. President Kunze requested this to be put on next month's agenda to discuss in more depth.

Rescue tool discussion.
